Compute Node Investment

Term

The term of this agreement is for five (5) years from the in-production service date of any nodes purchased after this agreement is executed. See the “Retirement Phase” section of the Overall Program Service Level Definition¹ for the disposition of equipment at the normal end of term. The final node configuration and in-production service date for all node purchases will be communicated with the Investor via the Illinois Campus Cluster Program (ICCP) ticketing system.

Service Overview

Investors in ICCP compute nodes also agree to the terms in the Illinois Campus Cluster Program Overall Program Service Level Definition.

The ICCP agrees to operate on behalf of the Investor, and in a manner consistent with the Illinois Campus Cluster Program Overall Program Service Level Definition and any other relevant governing policies, any compute nodes covered by this agreement.

Investors agree to invest in compute nodes on the Illinois Campus Cluster and to use them in accordance with ICCP and university policies.

Termination

Either party may terminate this agreement by providing written notification to the other party thirty (30) days in advance of termination. In the event of termination, Investors may receive the nodes in which they invested. All nodes of the number and type in which invested will be transferred to the Investor.

Storage

Each Investor in ICCP compute nodes receives **40GB** (usable) of User/Group Storage for every node in which they have invested. This allocation is governed per the terms in the Overall Program Service Level Definition.

Each standard ICCP compute node will be configured with **2TB** (raw) of node-local scratch storage space. This is in addition to shared scratch storage available via network mount from all standard ICCP compute nodes.
